# **DESCRIPTION**

105 Powdered Pigment are conveniently premeasured to individually tint any single bag of 105 Grout. 105 Powdered Pigment are pure, synthetic, iron oxide pigments that contain no fillers that will affect the performance of the 105 Grout tinted. Color consistency is maintained from bag to bag.

#### MIXING AND APPLICATION

105 Grout Mix

- 1. Add required 111 or 112 Modifier to a 5 gallon as directed by the 105 Powdered Pigment TDS.
- 2. Empty 105 Powdered Pigment into modifier prior to addition of the 105 grout.
- 3. Mix with a handheld concrete mixing paddle.
- 4. While mixing, add 105 Powdered Pigment as directed in appropriate TDS. Note: multiple bag batches may be appropriate; always maintain mix ratio of 1, 105 Powdered Pigment to 1, 105 Grout.

#### **SUITABILITY SAMPLE**

Because job site conditions and requirements can vary significantly, always prepare a sample.

#### **QUICK FACTS**

Packaging: 0.5 – 1.5 lb. sack varies by color selection

Coverage: 1, 105 Powdered Pigment to 1, 50 lb. bag of 105 Grout

Color: 9 Standard Colors

Shelf Life: Under normal conditions when kept dry, out of direct sunlight, the shelf life of an unopened sack is 12 months from the date of purchase. Storage must be under roof and off the floor. Rotate inventory to maintain product that is within limits.
